The proposed bylaw to restructure the out-of-state travel guidelines will be put to a vote by the State Board of Education on October 25<sup>th</sup>.

Schools are strongly cautioned not to assume final passage and *should not* make any out-of-state travel commitments beyond the current 300-mile limit until the vote is taken. Member schools will be alerted via e-mail should the Board approve the proposal.

The new proposal calls for:

- Travel restricted to USA
- No loss of instructional time
- Travel meets all guidelines of local school system policy.

# MPSSAA Adds New Staff Members

#### **Mary Lucas**

• The MPSSAA is pleased to announce that Mary Lucas has accepted the position of MPSSAA Coordinator of Information and Publications. Her major responsibilities will be to produce and distribute all MPSSAA printed materials as well as coordination of all media contacts with the Association.

Mary brings a vast amount of experience to this newly created position. For the past 31 years, she has taught physical education at Bladensburg High School in Prince George's County. She has also coached for many years, served as Department Chairperson and served on MPSSAA tournament committees. Several summers ago, Mary worked on reformulating the tournament bulletins format so they could be printed in a single booklet. Additionally, she has maintained the state track and field records and in recent years has produced a variety of athletic publications.

The MPSSAA is fortunate to be able to hire someone with Mary's background and expertise. She will be a valuable asset.

#### George McKelvie

The Association is happy to announce that George McKelvie has accepted the position of MPSSAA Coordinator of Officials. Among his major responsibilities will be coordinating the recruitment, training, testing, registration and rating of all athletic officials working contests at MPSSAA member schools.

George has spent the last 31 years as a professional educator in Baltimore County. He has served as teacher, department chairman, vice principal, and for the past 8 years principal of Golden Ring Middle School. During that time, George has also been an outstanding wrestling official. He has held the office of President of the MWOA and currently serves as their rules interpretor and college commissioner. George has officiated the MPSSAA State finals on several occasions, most recently the 1988 tournament. His outstanding organizational skills combined with his officiating experience should stand him in good stead as he undertakes this new position.

#### **Paybacks**

At the May 5 meeting of the MPSSAA Board of Control, a new comprehensive reimbursement policy was adopted. The new plan, to be implemented beginning next school year, calls for reimbursement to be paid in every sport in which an official State tournament is conducted. This added reimbursement will mean an additional 30 to 40 thousand dollars that will be distributed annually to member schools.

A special review committee made the recommendation to the Board of Control after careful study. This latest increase marks the 3rd straight year the Association has increased the distribution of funds. Two years ago travel mileage and meal allotment as well as workers and officials fees were increased by 25 to 33%. This past year district subsidies were substantially increased.

The new formula calls for:

1. Minimum travel reimbursement for mileage be raised

- from \$50 to \$75. All other criteria for those sports in which reimbursement is currently being paid would remain the same.
- For the sports of cross country, golf, indoor track, tennis, and track and field, schools would be given an allotment for participation based on the distance from tournament site. The allotment schedule is as follows:

#### Round trip distance to Site of Finals

Schools hosting a State tournament final will be given an award of \$300. This award would be made by separate check to the School Athletic Department.

**Applications Due April 15** 

#### **Coordinator Of Officials**

The MPSSAA is currently accepting applications for the position of Coordinator of Officials. This will be a half-time position with responsibility for the coordination of recruitment, training, testing, registrations, and rating of all athletic officials working contests at MPSSAA member schools.

The basic duties and responsibilities will include the registration of officials; coordinating the selection and notification of officials working playoff games; establishing an evaluation and rating system; establishing a statewide officials organization; as well as coordinating rule book sales.

The half-time salary will range from \$15,030 to \$19,824

based on experience and qualifications.

Position announcements have been sent to each school. Applications can be obtained from the MPSSAA, (301) 333-2300. The deadline for applications is April 15, 1988.
